No. 1/MSPC (R) -2023 In exercise of the powers conferred under Section 46 (2) clause (i) of the Pharmacy Act, 1948 and as resolved in the  $17^{\text{th}}$  General Body Meeting held on Wednesday, the  $2^{\text{nd}}$  August, 2023, in resolution number 17.7, the existing rate of fees in Part-XIII of the Manipur State Pharmacy Council Rules, 2003, in relation to Pharmacist Registration and others etc., has been revised as given below.

Further the validity of registration certificate will be extended from the existing validity period of 3 (three) years to 5 (five) years. This new rate of fee structure will be **effective from 1**st **September, 2023.**
